The data we gather

We process and hold personal data such as:

- 1. Your name and email address, and any other contact details which you have given to me
- 2. Data on how you engage with the content of my website www.co-active-coach.cu.uk
- 3. Information you provide to me while using my coaching services

How we gather data

We may collect data from you in person, through email, text, social media messaging, social media posting or any other communication that you send me, by you completing and signing a client contract form, or through you submitting a contact or sign-up form on our website, or through cookies on our website.

We may also receive your data from third parties, for example referrals, from search information providers such as Google, or from online networks such as Facebook or LinkedIn.

What we do with the personal data gathered, and the lawful reasons we collect it

Your data is exclusively to carry out our work, to serve you, and to communicate about the Coaching.

Security

We are committed to ensuring that your data is secure. To prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure your data.

How long we retain your data

We will retain your data for only as long as it is needed for the coaching purposes, or until you ask us to delete the data we hold.

Controlling your personal data

As the subject of personal data held about you, you have:

- 3. The right to rectification
- 4. The right to erasure
- 5. The right to restrict processing
- 6. The right to data portability
- 7. The right to object
- 8. Rights in relation to automated decision making and profiling.
